SUBJECT: New Temporary Certificate of Registration for Snowmobiles

Beginning July 17, 2012, the New York State Department of Motor Vehicles will offer an online registration renewal transaction for snowmobiles, which includes an optional 15-day temporary registration. Customers who renew a snowmobile registration online, but do not receive the new registration credentials before the old registration expires, can print a temporary certificate of registration on a home printer. The temporary registration will be valid for 15 days from the date the renewal transaction is completed.

The temporary registration certificate must be carried by the operator of the snowmobile during the 15-day temporary registration period. After the temporary registration expires, the snowmobile cannot be operated in New York State unless it has the new registration credentials.

The temporary registration certificate will have a watermark; the expiration date of the temporary registration will display in several locations within the watermark. A sample image of the new temporary registration certificate is attached. Because the certificate will be printed on a home computer, the paper and/or print quality may vary from document to document. To ensure that the registration is valid, the snowmobile's registration record should be checked whenever possible.
