TO: All Enforcement Agencies

SUBJECT: IRP Update – Electronic Image of IRP Registration Credentials (Cab Card)

Effective January 1, 2019, motor carriers will have the ability to carry IRP cab cards as an electronic image. Carriers will not be required to carry a paper IRP cab card.

All US states and Canadian provinces will be required to accept an electronic image of the IRP cab card.

During a roadside stop, registration credentials may be presented as an electronic image via computer, tablet, smart phone, or as a paper copy.

Regardless of the format presented, the document must be accurate, accessible and readable. Carriers have been notified and were given a recommendation to store electronic documents as a PDF, to ensure immediate access to the document while in areas without service or WiFi.

New York will continue to issue the original paper cab card. However, the electronic image is also available.

Samples of the electronic version of the NY IRP cab card and the Temporary Evidence of Apportioned Vehicle (TEAR) are attached for reference.

Please share this information with appropriate staff, including all road patrol enforcement. Thank you.
