SUBJECT: IRP Updates – Massachusetts Extension and Changes to California's Cab Card

Massachusetts

Massachusetts is requesting that each jurisdiction delay enforcement for apportioned vehicles registered to Penske Truck Lease, Inc. up to July 20, 2011. All accounts have been renewed, but the carriers have not received the cab cards. If you have any questions, please contact the Massachusetts Registry of Motor Vehicles IRP Department at (617) 351-9320.

California

To comply with requirements of the International Registration Plan and Performance Registration Information System Management, the California Department of Motor Vehicles made the following changes to California's cab card:

- In the upper left portion of the document, "Registrant" has been added after "Operator/Lessee".
- The USDOT number and the title of the registrant have been removed from the upper right portion of the document.
- When a carrier provides notification that the carrier responsible for safety is expected to change during the registration period, the statement "The carrier responsible for safety is expected to change during the registration period" will be printed under "Carrier Responsible for Safety" in the bottom left portion of the document.
- All references to a grace period have been removed from the document because California does not have a grace period.
