## DESCRIPTION OF ABSTRACT OF LIFETIME DRIVING RECORD

An Abstract of Lifetime Driving Record (form ABS-9) provides all the information in DMV's records for a person who has a permit, license or non-driver ID, including information that is older than the retention time periods required by the Vehicle and Traffic Law. However, the abstract may not include information from when the person's record was created.

The top section of the abstract shows personal information, license class and expiration date, status information (license status, military status, organ donor status, etc.), and any restrictions and endorsements the person has.

The line that shows License Class, Status, and Expiration is considered the record summary line.

THE RECORD SUMMARY LINE MAY BE USED TO DETERMINE THE STATUS OF THE DRIVER'S LICENSE OR DRIVING PRIVILEGE.

The record summary line will also show the type of document the person has (a permit, license, conditional license, restricted use license, or a non-driver ID card) and the date the document expires. The record summary line shows **NO NY LICENSE** if the person does not have a New York State driver license, permit or non-driver ID. There will be more than one record summary line if the person has a valid license in one class and a valid permit in a different class, and if the person has a valid non-commercial license while the commercial privilege is revoked or suspended. More detailed information about the record summary line is provided on the pages that follow.

Below the record summary line are sections and sub-sections that provide additional information. These sections and sub-sections are separated by asterisks. The sections are: **ACTIVITY, SUSPENSIONS/REVOCATIONS, CONVICTIONS/BAIL FORFEITURES, VESSEL/SNOWMOBILE, ACCIDENTS, and ADDRESS HISTORY.**

The **ACTIVITY** section shows: commercial driver license (CDL) history, permit history, driver education information, change of class or privilege, documents issued, merges, information that the NY license was surrendered to another jurisdiction; reciprocity information (a NY license issued on the basis of a valid license presented from another jurisdiction), impaired driving program.

The **SUSPENSIONS/REVOCATIONS** section shows two types of suspensions and revocations: scofflaws and non-scofflaws. Non-scofflaws and Scofflaws are listed separately and in order by effective date from newest to oldest. For out-of-state courts, the court's address and phone number are recorded as provided by the issuing jurisdiction.

**Non-scofflaws:** The type of sanction imposed (suspension or revocation) which results from reasons other than failure to answer a summons or pay a fine/surcharge/assessment. The following fields may appear:

- Reason (reason for sanction)
- Order Number
- Case Number (if applicable)
- Ticket Number (if applicable)
- Class Affected
- Civil Penalty (if applicable)
- Termination Fee (if applicable)

- Reason (reason for clearance)
- Out of State Information (if applicable)
- Rescission (if applicable)

**Scofflaws:** The suspension imposed as a result of failure to answer a summons or pay a fine, surcharge, or assessment. The following fields may appear:

- Suspension Date
- Reason (reason for sanction)
- Order Number
- Ticket Number
- Court Name
- Clear On (clearance date)
- Reason (reason for clearance)



The **CONVICTIONS/BAIL FORFEITURES** section lists conviction and bail forfeitures in order of violation date. The following fields may appear:

- Conviction/Forfeiture (violation description)
- Violation Date
- Conviction Date
- Location
- Penalty (if applicable)
- Points (if applicable)
- Commercial Vehicle
- Hazmat
- Ticket Number

The **VESSEL/SNOWMOBILE** lists suspensions and convictions for boats and snowmobiles.

**Vessel/Snowmobile Privilege Suspensions:** section lists boat and snowmobile suspensions in order of effective date. The following fields may appear:

- Suspension Effective Date
- Reason (reason for sanction)
- Order Number
- Ticket Number (if applicable)
- Civil Penalty (if applicable)
- Period (length of sanction)
- Clear On (clearance date)
- Reason (reason for clearance)

**Vessel/Snowmobile Convictions:** section lists boat and snowmobile convictions in order of violation date. The following fields may appear:

The **ACCIDENTS** section lists accidents in order of accident date. The following fields will appear:

The **ADDRESS HISTORY** section lists addresses on file in order of effective date. The following fields will appear:

- Posted (effective date)
- Type
- Address

- Country

## EXPLANATION OF LICENSE STATUS ON THE RECORD SUMMARY LINE

An expired license, permit, or non-driver ID card may still be recorded as valid. This designation refers solely to the status of the privileges extended to the person, not to the status of the person's current (or most recent) document.

**VALID:** Unless expired, full driving privileges are in effect for the class of license shown.

**SUSPENDED:** Driving privilege is temporarily withdrawn for class of license shown.

**REVOKED:** Driving privilege is withdrawn for class of license shown.

**CANCELLED:** Driving privilege in all classes has been cancelled.

**SURRENDERED:** The driver has voluntarily given up his or her driving privilege in all classes.

**APPROVED:** Driver is authorized to have driving privileges returned after revocation, but has not yet obtained a license or learner permit.

## NEW YORK STATE LIMITED DRIVING PRIVILEGES

When appropriate, the type of limited driving privilege will show after the License Class on the record summary line.

**CONDITIONAL:** A limited driving privilege granted to NYS-licensed drivers who are suspended or revoked for alcohol or drug-related convictions.

**CONDITIONAL PRIVILEGE:** A limited driving privilege granted to drivers licensed in other states who are suspended or revoked in NYS for alcohol or drug-related convictions.

**PRE-CONVICTION CONDITIONAL LICENSE:** A limited driving privilege granted to NYS-licensed drivers who are suspended in NYS for alcohol or drug-related violations and who are not yet convicted.

**PRE-CONVICTION CONDITIONAL PRIVILEGE:** A limited driving privilege granted to drivers licensed in other states who are suspended in NYS for alcohol or drug-related violations and who are not yet convicted.

**RESTRICTED USE:** A limited driving privilege granted to NYS-licensed drivers who are suspended or revoked for reasons other than alcohol or drug-related convictions.

**RESTRICTED USE PRIVILEGE:** A limited driving privilege granted to drivers licensed in other states who are suspended or revoked in NYS for reasons other than alcohol or drug-related convictions.

**POST REVOCATION CONDITIONAL LICENSE:** A limited driving privilege granted to NYS-licensed drivers who have ignition interlock devices as a probation condition, and who have completed the minimum revocation period required after an alcohol or drug-related conviction.

**LIMITED USE ENDING DATE (MM/DD/YYYY):** A limited driving privilege granted to junior drivers who pass their road test within 6 months of receiving a learner permit. After the ending date, full driving privileges are granted.

## NEW YORK STATE DRIVER LICENSE CLASSES

License class codes are used by every state as a national standard. Commercial driver licenses will appear on the record summary line as license class CDL A, B or C. A driver who has one class of license and obtains a motorcycle license or a learner permit for another class will have more than one record summary line to show the status of each license class. A driver with only a Class M or MJ license is limited to motorcycle operation. (Old classes were issued prior to 1991).
