Indiana is requesting that each jurisdiction delay enforcement for apportioned vehicles registered to J.B. Hunt Transport, Inc. from January 1, 2016 through January 31, 2016. All accounts have been renewed for 2016, but not all of the vehicles have the 2016 cab cards.

Indiana's Motor Carrier Services Division gave the carrier a letter to keep in each vehicle to serve as proof of valid registration until the new cab card is received. A sample of the letter is attached.
