SUBJECT: Chapter 409 of the Laws of 2010 - Elle's Law

Chapter 409 of the Laws of 2010, effective August 13, 2010, known as Elle's Law, amends section 510(2)(b)(xiv) of the Vehicle and Traffic Law, as amended by Chapter 571 of the Laws of 2006, to enhance license sanctions for a conviction of a violation of section 1146 (failure to exercise due care), where such violation caused serious physical injury to another person.

The following sanctions are mandated upon conviction of such a violation:

- For a first violation of section 1146 causing serious physical injury six month license suspension;
- For a second or subsequent violation of section 1146 causing serious physical injury committed within five years of a prior violation of 1146 causing serious physical injury one year license suspension.

CHAPTER 409

AN ACT to amend the vehicle and traffic law law, in relation to suspension of driving privileges

Became a law August 13, 2010, with the approval of the Governor.

Passed by a majority vote, three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Short title. This act shall be known and may be cited as "Elle's Law".

§ 2. Subparagraph (xiv) of paragraph (b) of subdivision 2 of section 510 of the vehicle and traffic law, as added by chapter 571 of the laws of 2006, is amended to read as follows:

(xiv) for a period of forty-five days where the holder is convicted of a traffic infraction for a first violation of article twenty-six of this chapter and the commission of such violation caused serious physical injury to another person, except: (A) where the holder is convicted of a traffic infraction for a first violation of section eleven hundred forty-six of this chapter and the commission of such violation caused serious physical injury to another person, the suspension shall be for a period of six months; and (B) where the holder is convicted of a traffic infraction for a second violation of section eleven hundred forty-six of this chapter and the commission of such violation caused serious physical injury to another person, and such person has previously been convicted of a traffic infraction for a violation of section eleven hundred forty-six of this chapter and the commission of such violation caused serious physical injury to another person within five years, the suspension shall be for a period of one year.

§ 3. This act shall take effect immediately.
