SUBJECT: IRP Updates Regarding Indiana and Mississippi

Indiana

Indiana issues one apportioned plate and one cab card per apportioned vehicle or trailer. An apportioned plate must be displayed on the front of tractors, dump trucks and truck-tractors, and on the rear of trucks, buses and trailers. Apportioned plates have the notation "APP" on the upper left corner.

The original Indiana cab card or temporary registration permit for the vehicle and, if hauling a trailer, the original cab card for the trailer must be carried in the vehicle. The cab card for power units and the temporary permit are 8 ½" x 11" and are printed on plain white paper. The state seal is printed in the upper corners and may display in color as green/yellow or in black and white. A bar code is printed in the bottom right corner. A sample of each is attached for reference.

The Indiana cab card for trailers is also printed on 8 ½" x 11" plain white paper with the state seal printed in color or black and white in both upper corners. However, the cab card for trailers does not have a bar code and is half of the sheet of paper in size. A sample is attached for reference.
