SUBJECT: IRP Update – Delaware Cab Card

Delaware has temporarily changed its cab card because of a production issue with the cab card paper. The cab card is temporarily being printed on 8 ½" X 11" paper without the perforation that normally enables the carrier to tear the cab card portion from the instructions that are printed on the lower half. Also, there is no accommodation on the back of the card for signatures. The sticker showing the expiration year is affixed on the lower right corner of the paper. A sample is attached for reference.
