<u>Maryland</u>

Maryland is now issuing redesigned cab cards. The new cab card measures  $8-1/2'' \times 11''$  and is printed in black ink on white paper. The card includes a logo, the Maryland state seal, as a watermark in the center of the paper. A sample is attached for reference. There will be a mix of valid cab cards in the previous format without the logo and in the new format until October 31, 2015.

### <u>Mississipp</u>i

Mississippi is now issuing redesigned cab cards. The new cab card measures  $8-1/2'' \times 11''$  and is printed in black ink on white paper. The card includes the Mississippi Department of Revenue seal as a watermark in the center of the paper. A sample is attached for reference. There will be a mix of valid cab cards in the previous format on "goldenrod" colored paper and in the new format through October 15, 2015.

Cab Cards that are copied, or altered, or list jurisdictions after the row of asterisks, are invalid. Maryland Law requires the vehicle to be insured at all times. Tags must be returned PRIOR to any cancellation of insurance on this vehicle. Failure to comply will result in suspension of the registration and penalty of up to \$2,500.00 per vehicle, per year.

The Maryland Vehicle Law requires that you provide your insurance information when involved in an accident. The Cab Card must be carried in this vehicle or on the person operating the vehicle.

Maryland Vehicle Law requires you to display both a front and rear license plate on the vehicles they are issued for. For Tractors, Truck Tractors and Road Tractors; validation stickers must be put on the Front License Plate.
