SUBJECT: IRP Update – Changes to New York State Credentials

As of October 20, 2010, New York is issuing newly designed IRP credentials as accounts renew. The following changes have been made to cab cards and temporary registrations issued to New York-based IRP vehicles:

- A barcode that includes PRISM information has been added at the bottom of the cab card;
- Above the barcode, a new section "Motor Carrier Responsible for Safety" has been added, which will provide the name, address, and US DOT number of the carrier who is responsible for the safety of the vehicle.

Samples of the new format are attached for your reference. Because the new IRP documents are being phased in, there will be a mix of valid cab cards and temporary registrations in the previous format and in the new format until all accounts have been renewed.
