SUBJECT: New York State Pilots a Redesigned Windshield Registration Sticker

Beginning December 8, 2010, the New York State Department of Motor Vehicles (DMV) will be conducting a pilot program to evaluate a new windshield registration sticker design. The pilot program will only involve IRP class commercial vehicle registrations (apportioned vehicles). These vehicles will be issued a redesigned windshield registration sticker and cab card that will serve as the official proof of registration.

The printed information on the windshield sticker and cab card that will be used in the pilot will remain the same as that on the current sticker and cab card, but the font on the windshield sticker will be larger. The new sticker will include the following security features to aid in determining a sticker's authenticity:

- There are two optically variable floating images:
 - 1. a wavy line appearing horizontally across the face of the sticker; and
 - 2. a small image of New York State appearing repeatedly throughout the face of the sticker.
- If an attempt is made to scratch-off the printed text, the gold body of the new sticker will scratch-off to reveal a white background.
- If a sticker is removed, a distinct checkerboard pattern will appear in the blue border around the perimeter of the sticker, and the border will separate from the document.

DMV plans to issue approximately 50,000 redesigned stickers for the pilot program. When the supply of 50,000 stickers is depleted, DMV will resume issuing the windshield registration sticker and cab card that are currently in use.




New IRP Windshield Registration Sticker (Optically variable wavy line is visible)
