SUBJECT: IRP Update - Redesigned Massachusetts Credentials

As of February 19, 2013, Massachusetts is issuing redesigned IRP credentials as accounts renew. The documents contain the same information as the previous credentials, but the format has changed. One of the most significant changes is the relocation of the barcode to the lower right corner; previously, the barcode was located slightly right of center. Samples of the new format are attached for your reference.

Because the new IRP documents are being phased in, there will be a mix of valid cab cards and temporary registrations in the current format and in the new format until July 1, 2013, when all accounts have been renewed.
