## **Emergency Declarations**

States continue to issue emergency declarations in response to severe weather conditions. ## Delaware - Redesigned Cab Cards

Delaware will start issuing redesigned cab cards on February 24, 2014. The new cab card is printed in black ink on white 8  $\frac{1}{2}$ " X 11" card stock paper. The state seal is printed at the top center. A bar code is located in the lower left corner and the sticker showing the expiration year is affixed on the lower right corner. A sample is attached for reference.

There will be a mix of valid Delaware IRP credentials in the current format and in the new format while the new IRP documents are phased in over the next 12 months. If you have any questions, please contact Robyn Bose at (302) 744-2720.
