(VERIFI) System and Temporary Certificate of Registration (TCR)

Vehicle Electronic Reassignment and Integrated Facility Inventory (VERIFI)

On August 13<sup>th</sup>, 2018 the Department of Motor Vehicles will begin utilizing the new VERIFI system to electronically facilitate sales of vehicles by licensed dealers. The system will also manage dealer inventory and maintain a historical record of all transactions. When fully implemented participation will be mandatory for dealers, with only limited exceptions.

New Temporary Certificate of Registration (TCR)

In conjunction with the new VERIFI system, at the time of vehicle sales a new style TCR document will be issued. This certificate will be affixed to the windshield in the same manner as currently required. The document will contain additional registration and sales information and be easier to validate. In the future, this registration information will be available for inquiries in the Integrated Justice Portal.

There will be limited situations where the old style TCRs will continue to be issued. In those instances, dealers will follow current procedures.
