SUBJECT: New Temporary License/Permit/Non-Driver ID

On July 23rd, 2015, the New York State Department of Motor Vehicles will begin offering a new temporary license or non-driver identification card (NDID) to customers who renew their document online. Customers replacing a license/permit/NDID online will also be offered a new temporary document. If the customer does not receive the new photo document before their photo document expires, the temporary document will provide the customer with proof their document has been renewed until their new document arrives.

Upon completing the online renewal or replacement transaction, the customer will be given the option to print the temporary document on a home printer. The temporary license/permit/NDID will be valid for 60 days from the date the renewal/replace transaction is completed. The temporary document will have a background image of the state coat of arms.

A sample image of the new temporary document is attached for your reference. Because the document will be printed on a home computer, the paper and/or print quality may vary from document to document. To ensure that the document is valid, the customer's record should be checked.
