#### SUBJECT: IRP Update – Redesigned Massachusetts Credentials

Massachusetts is issuing newly designed IRP credentials as accounts renew. The following changes have been made to cab cards and temporary registrations issued to Massachusetts-based IRP vehicles:

- The Massachusetts DOT letterhead is new;
- The registration year has been added under "Account Number";
- A barcode has been added that includes the following information:
  - Name and address of registrant
  - Vehicle information (Year, Make, VIN)
  - US DOT number
  - o Name and address of the Motor Carrier Responsible for Safety
  - Number of seats
  - Registration year
  - o Registration number, date of issuance, and expiration date
  - o Gross vehicle weight and registered weight
- A new section "Carrier Responsible for Safety" has been added to the left of the barcode. The carrier's name, address, and US DOT number will be printed below that heading when the carrier responsible for safety will not change during the registration year. If the carrier will change, the message "The carrier responsible for safety is expected to change during the registration year" will be printed below the heading.

Samples of the new format are attached for your reference. Because the new IRP documents are being phased in, there will be a mix of valid cab cards and temporary registrations in the current format and in the new format until all accounts have been renewed.
