SUBJECT: IRP Update – Redesigned Utah Credentials

Utah is issuing redesigned IRP credentials as accounts renew. The following changes have been made to cab cards and temporary registrations issued to Utah-based IRP vehicles:

- The cab card has been revised to include "IRP Carrier #" and "Effective Date."
- The temporary registration has been redesigned so its format and content are consistent with that of the cab card:
 - The seal of the State of Utah is printed as a gray watermark in the center of the document.
 - Registrant information, carrier information, and vehicle information have been reorganized into three separate sections.
 - The US Department of Transportation number has been added to the "Carrier Safety Information" section.

The cab card and temporary registration will continue to be printed on 8 ½" X 11" paper. Samples of the new format are attached for your reference. Because the updated IRP documents are being phased in, there will be a mix of valid cab cards and temporary registrations in the previous format and in the new format until all accounts have been renewed.
