## District of Columbia Experiencing an Increase in the Distribution and Abuse of Phencyclidine (PCP)

This report states that according to official records of the Metropolitan Police Department, the District of Columbia's Court Supervision and Offender Services Agency, and the Drug Enforcement Administration, the District of Columbia has experienced a significant increase in the distribution and abuse of PCP over the past several years. The current rate of adult arrestees testing positive for PCP is approximately 11 percent, an increase of more than 230 percent since 2004. PCP-related arrests in the District of Columbia have also increased steadily. There were a total of 583 PCP-related arrests in 2009, compared with 223 arrests in 2004—an increase of approximately 161 percent.

The data contained in this report are based on actual undercover heroin purchases made by DEA and its law enforcement partners on the streets of these cities.

#### The Drug Trade in Canada: A Threat Assessment

This report provides an assessment of the drug trafficking threat in Canada. It states that drug trafficking in Canada ranges from the domestic production of MDMA (3,4-methylenedioxymethamphetamine, also known as ecstasy) and high-potency marijuana to the smuggling of heroin, cocaine, and hashish into the country. Concentrated primarily in the west coast province of British Columbia and the eastern province of Ontario, trafficking organizations are often ethnic in nature and often specialize in one illicit drug.

#### **Black Cocaine**

This bulletin states that black cocaine, or *coca negra*, is created by drug traffickers to evade drug-detection canines and chemical field tests. The traffickers add charcoal, decolorizing carbon, fine iron filings, or various inorganic salts to cocaine, which transforms it into a dark, brittle substance that can be dark red, blue-violet, or black. It has no smell and does not react when subjected to field drug-testing methods. Black cocaine is not sold on the street in its black form; it is mixed with a solvent such as acetone or ether to extract the cocaine from the masking agents—i.e., iron thiocyanate and cobalt thiocyanate.

## **Liquid Methamphetamine Smuggled in Bottles**

The smuggling of methamphetamine from Mexico in liquid form is not new and is another means used by traffickers to thwart law enforcement interdiction efforts. Liquid methamphetamine is produced by dissolving the drug in water and then placing it in containers, usually empty, dark-colored liquor bottles. Officers may note that the liquid is slightly thicker than normal alcohol, that the bottle seals may be cut and glued, and that microscopic bubbles will float to the top of the liquid when it is shaken.

## Officer Safety—Highly Toxic Pesticide Encountered During Marijuana Eradication Operation in California

Operation Save Our Sierra (SOS) was a large-scale, multiagency marijuana eradication operation conducted in Fresno County, California, in July 2009. Large tracts of public lands are attractive to traffickers interested in establishing illicit marijuana grow sites at remote locations. During Operation SOS, California Department of Fish and Game wardens discovered a container of the highly toxic agricultural pesticide Metafos, aka methamidophos, at a grow site in the Sierra National Forest (within Fresno County) that the site tenders were apparently spraying on the marijuana.

### Multiton Load of Marijuana Seized From a Cloned School Bus Near Laredo, TX

On October 10, 2009, the Texas Department of Public Safety (TXDPS) Highway Patrol seized 2,458 kilograms (5,408 pounds) of marijuana from a cloned school bus in Webb County, near Laredo, Texas. The bus, which was being driven on northbound U.S. 59 at 8:11 a.m. on a Saturday, aroused the suspicion of a TXDPS Highway Patrol trooper because it was being driven in the left lane of the highway but was not passing other vehicles. The TXDPS trooper conducted a traffic stop, and when the bus came to a halt, the driver fled into the nearby brush.

### Global Positioning System (GPS) Tracking Devices Used by Drug Trafficking Organizations

This bulletin states that the use and concealment of GPS tracking devices in drug or currency shipments by drug trafficking organizations (DTOs) operating in the United States are rapidly increasing. In 2009, several incidents in which traffickers used tracking devices to monitor the movement of their illicit cargo were reported. The use of this technology by DTOs is significant, and law enforcement should be aware of its rapidly increasing use because these devices have both operational and officer safety implications.

### **Books and Magazines Used to Smuggle Drugs**

On June 19, 2009, U.S. Customs and Border Protection officers at the Washington-Dulles International Airport arrested a 70-year-old female U.S. citizen who arrived on a flight from Germany via Amsterdam, The Netherlands. The woman was attempting to smuggle 222.9 grams of marijuana into the United States. The marijuana was packaged in small, clear plastic bags concealed within a bundle of German magazines inside the woman's luggage.

Mexican drug trafficking organizations (DTOs) are using PAA instead of ephedrine/pseudoephedrine as a precursor because PAA is not as restricted or controlled as pseudoephedrine. This bulletin highlights two significant seizures in Mexico and discusses why some DTOs are now using PAA in methamphetamine production.

## **Drugs Smuggled Inside a Glass Case**

On October 29, 2009, at the Otay Mesa Cargo Facility, Otay Mesa, California, a license plate check of a commercial tractor-trailer revealed positive results for illegal activity in U.S. Customs and Border Protection (CBP) indices. CBP officers directed the driver of the commercial tractor-trailer to nonintrusive inspections and to secondary inspection for further assessment. The results of the secondary screening were positive. The CBP officers seized a total of 47 packages of marijuana, with a combined weight of 719.95 kilograms.

#### **Drug Concealments in Vehicle Frame Rails and Cross-Car Beams**

On November 21, 2009, Louisiana State Police troopers seized 7.2 kilograms of cocaine that had been elaborately concealed in the front frame rails of a 2007 Chevrolet Cobalt four-door sedan. The vehicle was stopped for a traffic violation on eastbound Interstate 10 in St. Martin Parish, Louisiana. The vehicle was searched with a drug-detector dog, and the dog alerted positively to the front of the vehicle for the presence of drugs. When the officers removed the plates, they discovered packages of drugs in the void spaces inside the frame rails.

#### Officer Safety Alert: Intelligence on Booby-Trapped Marijuana Bales in Arizona

Over the past 2 years, the El Paso Intelligence Center has received reports of marijuana bales booby-trapped with chemicals and other types of contaminants specifically intended to harm the law enforcement officers who opened the packages or came in contact with the drugs. There have also been reports of traffickers planting live ammunition inside marijuana bales so that if seized, the ammunition would explode when the bales were incinerated.

### **Electronically Controlled Dashboard Concealment**

On December 15, 2009, Special Agents from the DEA Oakland Resident Office and U.S. Immigration and Customs Enforcement in Newark, California, arrested an illegal alien from Mexico for possession of more than 10 pounds of crystal methamphetamine. The suspect drove a California-registered 2004 Ford Taurus four-door sedan equipped with a sophisticated hidden compartment in the vehicle's interior. The hidden compartment was on the dashboard in the area normally occupied by the passenger side airbag. An electric solenoid-operated after-market trunk latch salvaged from an unknown type of vehicle secured the airbag cover to the dashboard.

This bulletin states that traffickers continue to use innovative methods to smuggle drugs in their attempt to prevent law enforcement officers from stopping their movement into the United States. Various methods have been employed by traffickers to conceal drugs. This bulletin is a compilation of incidents in which smugglers have concealed drugs inside spools of thread, textile rolls, nylon rope, and industrial-size spools of thread.

### **Drugs Smuggled in Baby Items**

This bulletin states that child car seats and strollers come in many shapes and sizes, which could facilitate their use in drug smuggling. While car seats and strollers are manufactured with safety in mind, some have natural voids in which illegal drugs can be concealed. The base of a car seat usually contains open cavities and hollowed areas, which can be used for concealments. Illegal drugs can also be smuggled in the hollowed areas of the handles, legs, or base of baby strollers.

#### **Narcotics Concealed in Fire Extinguishers**

On January 16, 2010, Mexican Customs agents along with Mexican Navy personnel seized approximately 3.4 tons of ephedrine from the cargo vessel MSC *Paola* at the Port of Manzanillo, Colima, Mexico. While inspecting the vessel's cargo, officers discovered 2,000 fire extinguishers in two different sizes; 612 contained ephedrine. Some of the extinguishers contained ephedrine powder weighing more than a ton, while others contained 327 kilograms of ephedrine pills.

### **Ambulance Used for Drug Smuggling Interdicted in Arkansas**

On January 24, 2010, Arkansas State Police troopers seized 105 pounds of marijuana from an ambulance on Interstate 40 in Faulkner County, Arkansas. The ambulance, a 2001 Ford Expedition sport-utility vehicle, was stopped for a traffic violation on eastbound Interstate 40 near Conway, Arkansas. The vehicle, which was painted white with orange emergency stripes on the sides, had blue EMT-style medical decals on the rear-side quarter windows, red emergency lights mounted above the front bumper, and a red emergency light bar mounted on the roof. The driver and passenger of the ambulance were residents of Oroville, California, and had in their possession healthcare industry-style identification badges from a mental health facility where they had previously been employed.

#### **Cloned Cargo Vans Used for Marijuana Smuggling**

The Texas Department of Public Safety Criminal Investigation Division office at McAllen, Texas, has reported the use of cloned Eagle Global Logistics (EGL) cargo vans in the transportation of marijuana. EGL was bought by CEVA Logistics in August 2007, and EGL is no longer in existence. Intelligence has indicated that a commercial sign shop in Pharr, Texas, has been painting and decaling Chevrolet and GMC cargo vans to resemble EGL vehicles. It is believed that the sign shop is knowingly providing vehicle cloning services to traffickers who then use the vehicles to transport drugs.

#### A Powerful New Designer Drug-Ivory Wave

According to open-source reporting, a powerful new mind-altering drug has surfaced—one so addictive that users say it provokes an almost uncontrollable urge for another hit. The drug, Ivory Wave, is available on Internet web sites based in Europe, which disguise the drug's true identity by selling it as a soothing bath salt. The companies that market Ivory Wave also sell other bath salt products, which are believed to contain similar ingredients.

#### **Decoy Smuggling Vehicle Discovered Near Arizona Border**

On February 6, 2010, U.S. Customs and Border Protection agents received a report from a concerned citizen about a suspicious vehicle that had been abandoned near Hereford, Arizona. The agents proceeded to the area and discovered a 2008 Chevrolet Avalanche pickup that had been left running without a key in the ignition. When the agents searched the pickup, they discovered what appeared to be numerous bundles of marijuana in the rear passenger area and in the pickup bed. Upon opening the bundles, the agents found only wood chips. It is believed that this pickup was intended as a decoy smuggling vehicle to divert attention from an actual drug movement event.

## Liquid Methamphetamine Hidden Inside Windshield Washer and Radiator Overflow Reservoirs of 2005–2007 Jeep Liberty Vehicles

Historically, liquid methamphetamine has mostly been smuggled into the United States via passenger flights and found inside different types of containers (such as wine bottles or other types of bottles) hidden inside packages or luggage. ## **Drug Trafficking Organizations Find Substitute for Pseudoephedrine**

Drug traffickers in Mexico have started using phenylacetic acid in place of pseudoephedrine to produce crystal methamphet-amine. This chemical is also used to produce perfume, but according to the Mexican Secretary of Health, José Ángel Córdova Villalobos, the increase in phenylacetic acid importation in the country does not correlate with an increase in perfume production. Instead, increases in its importation are attributed to its use in crystal methamphetamine production.

Comment: Events leading up to the use of phenylacetic acid in place of pseudoephedrine began when the importation of pseudoephedrine was banned after Felipe Calderón took office.

His ranking within the cartel was considered to be similar to that of Joaquín Guzmán Loera, aka El Chapo, and Ignacio Coronel Villareal, aka Nacho Coronel, the main leaders of the Sinaloa Cartel. Zambada allegedly replaced Alfredo Beltrán Leyva in 2008 and was in charge of drug shipments from Colombia and their distribution in the Federal District, Morelos, and Mexico State.

This operation covered Córdoba and Urabá, Colombia, and transported drugs directly to Central America and Mexico.

From February 6 through February 17, 2010, Mexican marines destroyed marijuana and poppy plants in three separate operations. Between February 6 and February 15, marines from the 4th Naval Zone conducted operations in multiple locales throughout Sinaloa, including Juchimen, Los Venados, Jajalpan, La Catalina, Rincón de los López, Ciénega de los Lara, El Tiro, La Cieneguilla, Rincón de los Montes, El Chicorato, El Otatilo, Bagrecitos, Lo de Félix, Agua Amarilla, Malpais, and Morirato. Of the OTPs that provided methadone maintenance and/or buprenorphine maintenance services, 52.4 percent served only clients in the maintenance program, and 47.6 percent served clients in the maintenance program as well as other substance abuse clients.
